Trump urges slowdown in Covid-19 testing, calling it a 'double-edge sword'

A White House official said Trump was joking about his call for a slowdown in testing

US PRESIDENT DONALD Trump on Saturday told thousands of cheering supporters he had asked US officials to slow down testing for the novel coronavirus, calling it a "double-edged sword" that led to more cases being discovered.

Trump said the United States had now tested 25 million people, far more than other countries.

"When you do testing to that extent, you're gonna find more people you're gonna find more cases. So I said to my people slow the testing down, please," Trump told a campaign rally in Tulsa, Oklahoma, where many supporters were not wearing face masks.

A White House official said Trump was joking about his call for a slowdown in testing.

"He was obviously kidding. We are leading the world in testing and have conducted 25 million + in testing," the official said.

Trump said his actions in blocking travellers from China and Europe had helped save "hundreds of thousands of lives." But he said the "radical



fake news" media had not given him credit for doing what he called "a phenomenal job" responding to the out-

In fact, several US states are reporting troubling spikes in coronavirus infection rates, mainly in the South and West, as Trump addressed America's largest indoor gathering in months.

Health experts say expanded diagnostic testing accounts for some, but not all, of the growth in cases. They also call it a key tool in fighting the spread of the disease, which had been detected in at least 2.23 million people across the United States as of Saturday.

Covid-19, the disease caused by the novel coronavirus, has killed more than 119,000 Americans to date, according to Reuters' running tally. A mounting volume of infections is elevating hospitalisations in some places.

In his remarks, Trump used terms such as "Kung Flu" virus

and "Chinese virus" to refer to Covid-19. "That name gets further and further away from China, as opposed to calling it the Chinese virus," he said.

Trump's response to the outbreak has sapped his popularity.

The US president initially dismissed the threat of the coronavirus, and sparred with state governors as they tried to slow its spread. His approval ratings have dropped in recent weeks, and Democratic presidential candidate Joe Biden now has a 13-point lead over Trump. Seventy-six percent of

Americans remain concerned about the spread of Covid-19, according to the latest Reuters/Ipsos poll.

Trump slams protests, defends pandemic response as Tulsa crowd underwhelms

President Donald Trump, addressing a less-than-full arena for his first political rally in months, blasted anti-racism protests and defended his handling of the coronavirus on Saturday in a bid to reinvigorate his re-election campaign. The president, who revels in

large crowds and had predicted that his first rally in months would be epic, blamed the media for discouraging attendees and cited bad behaviour by demonstrators outside, but did not specifically acknowledge that many seats in the 19,000-seat BOK Center arena were empty.

The president, who has encouraged a militaristic response to the nationwide demonstrations while being accused of showing a lack of empathy for the plight of Black Americans, used his speech to take aim at some of the pro-

TikTok users and K-Pop fans say they sank **Trump rally**

PRESIDENT TRUMP'S campaign promised huge crowds at his rally in Tulsa, Oklahoma, on Saturday, but it failed to deliver. Hundreds of teenage TikTok users and K-pop fans say they're at least partially responsible.

Brad Parscale, the chairman of Trump's reelection campaign, posted on Twitter on Monday that the campaign had fielded more than a million ticket requests, but reporters at the event noted the attendance was lower than expected. The campaign also cancelled planned events outside the rally for an anticipated overflow crowd that did not materialise.

Tim Murtaugh, a spokesman for the Trump campaign, said protesters stopped supporters from entering the rally, held at the BOK Center, which has a 19,000-seat capacity. Reporters present said there were few protests.

1 man dead, 11 wounded in Minneapolis shooting

ONE MAN IS dead and 11 people suffered non-life-threatening wounds in a shooting in Minneapolis, police there said early on Sunday.

Minneapolis police had first said 10 people had been shot with 'various severity levels of injuries', but revised their total in a tweet posted just after 3 am. The name and age of the deceased weren't immediately released, and it wasn't clear whether anyone was taken into custody.

An initial tweet from Minneapolis police advised the public to avoid the area in Uptown Minneapolis, a commercial district that includes several bars and restaurants.

Minnesota began allowing bars and restaurants to reopen with limited service on June 1 after some six weeks of closure because of the coronavirus pandemic. Photographs posted to social media showed windows at the Landmark's Uptown Theatre and another storefront shot out.

Screams were audible on a live video posted to Facebook that showed the aftermath at

the scene. Small crowds of people gathered, with some crouched over victims lying on the pavement before police officers on bicycles showed up to attend to them. Splatters of blood were visible on the pavement after the vic-

pitals. The area is about 5 kilometers west of the Minneapolis commercial area and neigh-

tims were taken to local hos-

bourhood hit by rioting in the wake of George Floyd's May 25 death after being arrested by Minneapolis police.

Floyd's death has sparked a move to overhaul the Minneapolis Police Department, with a majority of City Council members pledging support for dismantling a department that many community activists have called brutal and racist. That's prompted pushback from opponents who question how citizens will be protected from violent crime. Even the most aggressive proponents for change have acknowledged it's many months away and they're not

THEY SAY HE hires protesters

George Soros, the billionaire investor and philanthropist who has long been a target of conspiracy theories, is now being falsely accused of orchestrating and funding the protests over police killings of Black people that have roiled the United States. Amplified by a growing number of people on the far right, including some Republican leaders, online posts about Soros have skyrocketed in recent weeks.

They have been accompanied by online ads bought by conservative groups that call on authorities to 'investigate George Soros for funding domestic terrorism and his decades-long corruption'. Sorous, 89, has donated billions of dollars of his personal wealth to liberal and anti-authoritarian causes around the world, making him a favoured target

among many on the right. The Hungarian-American, who is Jewish, has also been the subject of anti-Semitic attacks injustice. and conspiracy theories for decades.

Such hoaxes can now travel farther and faster with social media. Over just four days in late May, negative Twitter posts about Soros spiked from about 20,000 a day to more than 500,000 a day, according to an analysis by the Anti-Defamation League.

The Institute for Strategic Dialogue, a London think tank focused on extremism and polarisation, found an even more pronounced jump on Facebook, where there were 68,746 mentions of Soros in May. The previous record of 38,326 Soros mentions was in October 2018, when angry posts alleged he was helping migrant caravans headed to the US.

The new wave began as nationwide demonstrations emerged over George Floyd's death at the hands of Minneapolis police. Some insist Soros financed the protests, while others say he colluded with police to fake Floyd's death last month. But all available evidence suggests the protests are what they seem: gatherings of thousands of Americans upset about police brutality and racial

there.

"I think partly it's an attempt to distract from the real matters at hand? the pandemic, the protests or the Black Lives Matter movement," Laura Silber, chief communications officer for Soros' philanthropic Open Society Foundations, said of the theories."It's pretty demeaning to the people out there protesting when someone says they're all paid. It's insulting."

Experts who study conspiracy theories say the new claims about Soros are a way to delegitimize the protests and the actual reasons behind them. Some see anti-Semitism, or a new spin on the age-old hoax that a shadowy cabal of rich men? whether it's the Illumi nati, the Rothschilds, the Rockefellers, Bill Gates or Soros? is manipulating world events.

The theories have had realworld consequences. In 2018, amid news of caravans of migrants making their way toward the U.S.-Mexico border. online misinformation about Soros was linked to violence. Cesar Sayoc, a Florida man who was obsessed with Trump, mentioned Soros dozens of times on social media before mailing pipe bombs to newsrooms, top Democrats and Soros himself.

Vivo may seek negotiated exit from IPL

PepsiCo India's midway exit in 2015 had set a precedent, say experts

he Indian Premier League (IPL) governing council will meet this week to review all sponsorships of the T20 tournament, counted among the world's most-valuable sporting properties. The move comes as pressure to boycott Chinese goods increases following the last week's stand-off between Indian and Chinese soldiers in Ladakh.

On Sunday, the Confederation of All India Traders (CAIT), which has launched a nationwide campaign against Chinese goods, urged the Board of Control for Cricket in India (BCCI) and the Indian Olympic Association (IOA), to cancel sponsorships of Chinese firms. "They should immediately cancel sponsorships of Chinese firms, if any, in the interest of the nation," said Prayeen Khandelwal, secretary general, CAIT.

A 2019 study by consultancy firm Duff & Phelps had valued the IPL at \$6.8 billion, up from 7 per cent the previous year. The BCCI, which owns and runs the league, is looking to organise the tournament somewhere in September-October this year after it was forced to cancel its springtime schedule because of the Covid-19 pandemic.

IOA Treasurer Anandeshwar Pandey has called a meeting of its executives this week to decide on suspending an agreement with Chinese firm, Li-Ning, as sponsor of player kits.

IPL, on the other hand, has a deeper Chinese connect, with popular brands such as Vivo, Dream11 and Paytm associated with it. Vivo, which is the country's second-largest smartphone player, is the title sponsor of IPL, which it bagged in 2018 for nearlv ₹2.200-crore.

Malls see 77% degrowth infirst half of June: Study



Malls witnessed 77 per cent and high street retailers to degrowth while high street retail showed a decline of 61 per cent in business in the first half of June, as compared to the same period last year, with consumer sentiment remaining low even after lockdown relaxations, a report said.

According to the survey conducted by the Retailers Association of India (RAI) with participation of more than 100 big and small retailers, it was found that lockdown relaxations did not benefit retailers as there was no significant surge in their business.

कर्ज से मुक्ति, कम पूंजीगत खर्च, और एआरपीयू वृद्धि से आये बढ़ाने में मिलेगी मदद

लायंस इंडस्ट्रीज आरआईएल का शेयर शुक्रवार के कारोबार में 6.2 फीसदी चढ गया था और 1.759.50 रुपये के नए ऊंचे स्तर पर बंद हुआ। कंपनी ने यह घोषणा की है कि जियो प्लेटफॉर्म्स में निवेश और अपने राइट्स इश्यू के पूरा होने के बाद वह अब कर्ज-मुक्त हो गई है। इसके बाद उसके शेयर में तेजी देखने को मिली। तेजी की वजह से यह शेयर मार्च में अपने निचले स्तरों से

लगभग दोगुना हो गया है। विश्लेषकों को इसकी वजह यह है कि आरआईएल का शेयर पर इसका असर दिखा शेयर मार्च 2021 है कि आय वृद्धि से ऋण में तक २,००० रुपये और आएगी आखिरकार उसकी वित्तीय स्थिति मजबूत होगी। अनुमान है समेकित इकाई के लिए वित्त वर्ष 2020 का ब्याज

खर्च 22.000 करोड़ रुपये से ज्यादा है जो एक साल पहले की अवधि के मुकाबले 33 फीसदी बढ गया है। वहीं कर्ज-मुक्ति तेल एवं रसायन सेगमेंट में 20 फीसदी हिस्सेदारी अरामको को 1.14 लाख करोड रुपये में बेचे जाने और फाइबर तथा टावर परिसंपत्तियों की बिक्री पर निर्भर करेगी। यह ये सौदे पूरे होते हैं तो कंपनी सकल स्तर पर भी कर्ज-मुक्त हो जाएगी। हालांकि कुछ विश्लेषकों को मानना है कि ऊंचे कर्ज की वजह से कोष उगाही गतिविधियों पर नियंत्रण रहेगा। कोविड-19 महामारी और तेल एवं गैस खंड में कमजोरी को देखते हुए जहां आय वृद्धि अल्पाविध में प्रभावित हो सकती है, वहीं कंपनी के



निफ्टी के पिछला बंद स्तर 10,244 को (100 दिन के मुविंग एवरेज से ऊपर) अहम तकनीकी संकेतक माना जा रहा है। ज्यादातर ट्रेडर की निगाहें 10,350 पर जमी हुई है. एक ऐसा स्तर जहां से 50 शेयरों वाला इंडेक्स पिछले सप्ताह दो बार पीछे लौटा। तकनीकी विश्लेषकों ने कहा, अगर निफ्टी इस स्तर के पार जाने में कामयाब रहता है तो अगला स्तर 10,550 हो सकता है। कुछ विश्लेषकों का मानना है कि बैंकिंग शेयरों और दिग्गजों मसलन रिलायंस इंडस्टीज की मजबत रफ्तार निफ्टी को 10,350 के पिछले अवरोध को पार करने में मदद कर सकती है। एक विश्लेषक ने कहा, अगर एचडीएफसी और एचडीएफसी बैंक व आरआईएल की तेजी बनी रहती है तो बाजार तकनीकी अवरोध को पीछे छोड़ सकता है और अन्य शेयरों को आगे बढ़ने के लिए सहारा दे सकता है। उच्च उतारचढ़ाव के बावजूद बेंचमार्क निफ्टी पिछले हफ्ते 2.7 फीसदी चढा और इस तरह से मिडकैप सूचकांकों से उसका प्रदर्शन बेहतर रहा। *-सुंदर सेतुरामन*

बॉन्डों की बिक्री के मामले में मिडकैप फर्मों की रफ्तार होगी धीमी

रेटिंग एजेंसियों को लग रहा है कि मध्यम आकार वाली कंपनियों की तरफ से नए बॉन्ड की रफ्तार घट सकती है और ये कंपनियां महामारी व आर्थिक अनिश्चितता की पृष्ठभूमि में अपने पुंजीगत खर्च में देर कर सकती हैं। एक रेटिंग एजेंसी के वरिष्ठ विश्लेषक ने कहा, उस सीमा तक हम रेटिंग से संबंधित राजस्व के स्रोत पर कुछ असर देख सकते हैं। हालांकि बड़े आकार की फर्मों का रेटिंग एजेंसियों के साथ मोटे तौर पर गठजोड़ होता है। अप्रैल में वैसी ऋण प्रतिभूतियों की वैल्यू 5.14 लाख करोड़ रुपये रही, जहां रेटिंग या तो वापस ले लिया गया था या फिर उसे निलंबित किया गया था, जो मार्च के 2.12 लाख करोड रुपये के मुकाबले दोगुने से ज्यादा है। विशेषज्ञों ने कहा कि इसकी आंशिक वजह यह हो सकती है कि छोटे आकार की फर्में बॉन्ड जारी करने के अपने कार्यक्रम पर विराम लगा रही हैं और रेटिंग की वापसी का अनुरोध कर रही हैं।

ओएफएस की खुदरा मांग में रही सुस्ती

एचडीएफसी ऐसेट मैनेजमेंट कंपनी और एसबीआई लाइफ इंश्योरेंस का ऑफर फॉर सेल (ओएफएस) खदरा श्रेणी में परा आवेदन पाने में नाकाम रहा जबकि संस्थागत निवेशकों की मांग मजबत बनी रही। 2 लाख रुपये तक निवेश करने वाले खुदरा निवेश माने जाते हैं और ऐसे निवेशकों ने पूरे शेयरों के लिए बोली नहीं लगाई जबकि आर्बिट्रेज का फायदा सामने था। एचडीएफसी एएमसी और एसबीआई लाइफ की द्वितीयक बाजार में कीमत, ओएफएस के लिए तय आधार कीमत से ज्यादा थी। एक खुदरा ब्रोकरेज के अधिकारी ने कहा, खुदरा निवेशकों के बीच इस जानकारी का अभाव है कि ओएफएस में कैसे आवेदन किया जाता है और हमें किस कीमत पर बोली लगानी चाहिए। नियामक को प्रक्रिया आसान बनानी चाहिए। -समी मोडक

निजीकरण की बात हालांकि ऐसे समय में हो रही है जब पीएसयू फर्मों ने अपनी शेयर कीमतों और बाजार पूंजीकरण में काफी गिरावट का सामना किया है और व्यापक बाजार के मुकाबले उनका प्रदर्शन लगातार कमजोर बना हुआ है। पिछले 10 वर्षों में बीएसई 200 इंडेक्स (बैंक व वित्तीय कंपनियों को छोड़कर) 17 अग्रणी पीएसयू का संयुक्त बाजार पुंजीकरण 41 फीसदी घटा है जबिक सेंसेक्स में 91 फीसदी की गिरावट दर्ज हुई है।

इन 17 पीएसयू का संयुक्त बाजार पुंजीकरण 17 जून को 7.7 लाख करोड़ रुपये था, जो अप्रैल 2010 के 13.04 लाख करोड़ रुपये और जून 2019 के 12.2 लाख करोड़ रुपये के मुकाबले काफी कम है।

विनिवेश की संभावना वाली अग्रणी कंपनियों भारत पेट्रोलियम कंटेनर कॉरपोरेशन और कॉरपोरेशन (कॉन्कोर) ने हालांकि इस प्रवृत्ति को उलट दिया है और अपनी सकमक्ष कंपनियों के मुकाबले बड़े अंतर से बेहतर प्रदर्शन किया है। यह अलग बात है कि जनवरी से इनमें थोड़ी कमी देखी गई है।

बिजली उपकरण विनिर्माता बीएचईएल सबसे ज्यादा पिछडी हुई है और उसका बाजार पूंजीकरण अप्रैल 2010 के 1.2 लाख करोड़ रुपये के मुकाबले 90 फीसदी घटकर अभी 11,000 करोड़ रुपये रह गया है।

पिछले दशक के मुकाबले पिछडने वाली अन्य बड़ी कंपनियां हैं सेल (अप्रैल 2010 से 87 फीसदी नीचे), ओएनजीसी (53



फीसदी नीचे), एनएमडीसी (78 फीसदी नीचे), एनटीपीसी (47 फीसदी नीचे), नालको (79 फीसदी नीचे), कोल इंडिया (60 फीसदी नीचे) और गेल (20 फीसदी नीचे)।

बुधवार को वेदांत के चेयरमैन अनिल अग्रवाल ने कहा था कि निजीकरण के लिहाज से बीएचईएल आदर्श उम्मीदवार है। साल 2002 में वेदांत ने हिंदुस्तान जिंक का अधिग्रहण किया था, जो अभी समूह की दुधारू कंपनी है और सबसे ज्यादा लाभकारी धात् उत्पादक। वित्त वर्ष 2019 में हिंदुस्तान जिंक का योगदान वेदांत के एकीकृत राजस्व में 23 फीसदी रहा और ब्याज व कर पूर्व लाभ में उसकी हिस्सेदारी 55 फीसदी रही। समूह ने बीपीसीएल में दिलचस्पी दिखाई है।

बिजनेस स्टैंडर्ड के नमूने में शामिल 17 पीएसयू में से 12 ने पिछले 10 साल में बाजार पूंजीकरण में गिरावट दर्ज की है, वहीं पांच ने बढ़ोतरी देखी है। बीपीसीएल का प्रदर्शन सबसे अच्छा रहा और पिछले दशक के मुकाबले उसका बाजार पुंजीकरण चार गना हो गया। अप्रैल 2010 के 18,722 करोड रुपये के मुकाबले यह अभी 80,000 करोड़ रुपये है।

बढत वाली अन्य कंपनियां हैं एचपीसीएल (205 फीसदी बढ़त), पावर ग्रिड (81 फीसदी), इंडियन ऑयल (11 फीसदी) और कॉन्कोर (40 फीसदी)।

पिछले वर्ष पीएसय शेयरों के लिए मुश्किल भरे रहे हैं और संयुक्त बाजार पूंजीकरण (बैंक व वित्तीय फर्मों को छोड़कर) जून 2019 से अब तक 36 फीसदी टूटा है जबिक सेंसेक्स में 15 फीसदी

की गिरावट आई है। इसमें कॉन्कोर (पिछले 12 महीने में 33 फीसदी नीचे) और बीपीसीएल (7.2 फीसदी नीचे) शामिल है। बिजनेस स्टैंडर्ड की तरफ से संग्रहित आंकडों से पता चलता है कि जनवरी से अब तक यह गिरावट तेज रही है।

बीपीसीएल ने अपना बाजार मुल्यांकन 25 फीसदी यानी 26,000 करोड़ रुपये गंवाए, वहीं बीएचईएल ने 27 फीसदी। बीईएमएल ने 36.3 फीसदी गंवाए जबिक कॉन्कोर ने अपने मुल्यांकन का 30 फीसदी गंवा दिया यानी 10,500 करोड रुपये। शिपिंग कॉरपोरेशन ऑफ इंडिया ने इस साल अब तक 20.4 फीसदी की गिरावट आई है।

इनके अलावा सरकार ने एयर इंडिया के लिए बोली मंगाई है, लेकिन एक बोलीदाता ने कहा कि उन्हें इस पर दोबारा विचार करना होगा क्योंकि सभी सूचीबद्ध विमानन कंपनियों का बाजार पूंजीकरण 50 फीसदी से ज्यादा ट्ट गया है।

बैंकरों को डर है कि सरकार को वित्त वर्ष में विनिवेश लक्ष्य परा करने में परेशानी होगी क्योंकि उसे कम कीमत पर शेयर बेचने का फैसला करना होगा या फिर मुश्किल वक्त टल जाने तक इंतजार करना होगा।

बजट में सरकार ने 2.1 लाख करोड़ रुपये का विनिवेश लक्ष्य तय किया था, जिसमें पीएसबी व वित्तीय संस्थानों से 90,000 करोड रुपये हासिल करना शामिल है। सरकार बीमा दिग्गज एलआईसी के विनिवेश और आईडीबीआई की बाकी हिस्सेदारी बेचने पर भी विचार कर रही है।

एफपीआई ने जून में किया 17,985 करोड़ रुपये निवेश

विदेशी पोर्टफोलियो निवेशकों (एफपीआई) ने नकदी की बढ़ती उपलब्धता और उच्च जोखिम के बीच जुन में अब तक भारतीय पूंजी बाजारों में शुद्ध रूप से 17,985 करोड रुपये का निवेश किया है। डिपॉजिटरी के ताजा आंकड़ों के अनुसार, एफपीआई ने एक से 19 जुन के बीच इक्विटी में 20,527 करोड़ रुपये का शुद्ध निवेश किया। हालांकि उन्होंने ऋणपत्रों से 2,569 करोड रुपये की शुद्ध निकासी की। इस तरह आलोच्य अवधि में घरेलू पूंजी बाजार में उनका कुल शुद्ध निवेश 17,985 करोड़े रुपये हो गया। इससे पहले, विदेशी निवेशक लगातार तीन महीनों तक शुद्ध बिकवाल बने रहे। उन्होंने मई में 7,366 करोड़ रुपये, अप्रैल में 15,403 करोड़ रुपये और मार्च में 1.1 लाख करोड़ रुपये की रिकॉर्ड निकासी की थी।

ग्रो के सह-संस्थापक एवं मुख्य परिचालन अधिकारी हर्ष जैन ने कहा, जैसा कि दुनिया भर में अर्थव्यवस्थाएं तरलता बढा रही हैं, इक्विटी जैसे उच्च जोखिम वाले निवेश के लिए उत्सुकता भी काफी बढ रही है। यह पैसा भारत की तरफ भी आएगा क्योंकि भारत उभरते बाजारों में अच्छी स्थिति में है। उन्होंने कहा कि घरेलू और व्यक्तिगत उत्पादों, तेल और गैस तथा दूरसंचार क्षेत्र शेयरों ने पिछले महीने में सबसे अधिक एफपीआई आकर्षित किया है। कोटक सिक्योरिटीज के कार्यकारी उपाध्यक्ष एवं मौलिक शोध के प्रमख आर ओझा के अनसार, व्यावसायिक गतिविधियां धीरे-धीरे फिर से शुरू होने और बैंकिंग व वित्तीय सेवा क्षेत्र से मिल रहे कछ सकारात्मक संकेती के कारण बाजार की धारणा बेहतर है।
